

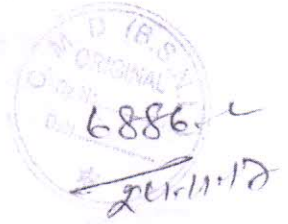

### OFFICE MEMORANDUM

Sub: - Pension Sanctioning authority for IDA pensioners and custody of Service books of IDA Pensioners regarding.

The undersigned is directed to refer this office letter No.7-77/2013/TA-1/2464-2488 dated 03-06-2013, where in instructions were issued to Heads of CCA for declaring Joint CCA (Admin)/ Dy.(CCA) Admin as Pension Sanctioning Authority in respect of CDA pensioners and to make systematic efforts in a phased manner to collect the service records of all DoT employees who retired on or before 30-09-2009 from BSNL/MTNL.

2. In partial modification to the above orders, the competent authority has directed that the Pr.CCA/CCA may declare Joint CCA (Admin)/ Dy. CCA (Admin) as Pension Sanctioning Authority in respect of CDA pensioners as well as IDA pensioners as per provisions of Rule 3 and 58 to 61 read with provision of Rule 37-A of CCS Pension Rules 1972,

3. Further it is directed that the service books of all the pensioners in respect of CDA should be collected in a phased manner and kept in the safe custody of respective office of Pr.CCA/CCA, as contained in rule 288(e) of FHB Volume -I by 15-01-2018. Where as in the case of the IDA Pensioners service books, this will be taken up at a later date which will be duly informed: The Pension related records for the IDA Pensioners, however are to be collected, completed and kept in safe custody by all Pr.CCA/CCA if not already available with the same by 15.02.2018.

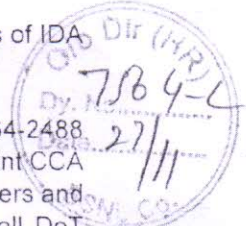
