
Sub:- Applicability of all the rules and regulations related to LTC in BSNL - Reg.

A Committee was constituted to examine the applicability of all the rules and regulations related to Leave Travel Concession (LTC) in BSNL. The recommendations of the Committee has been examined in consultation with Estt. Finance Branch, BSNL C.O. The undersigned is directed to convey the approval of the Competent Authority for implementation of the following:-

For ITS officers deployed & the employees on deputation in BSNL: The benefits of both All India as well as Home Town LTC to Government officers deployed in BSNL and on deputation, will be as admissible as per the existing orders of DOT, with additional flexibility to travel by private airlines subject to the conditions that the fare should not in any case, exceed LTC 80 fare of Air India.
