Sub: Rotation of officers working in sensitive posts – regarding.

Please find enclosed herewith CVC OM No. 18/MISC/02-392171 dated 23-08-2018 vide which CVC has issued instructions regarding rotation of officers working in sensitive posts. Commission has desired to effect rotational transfers in respect of those officers in sensitive posts who are continuing beyond 3 years.

This office vide letter no. 21-10/2018-VA dated 03.05.2018 has already issued instructions regarding rotation of officers from sensitive posts who are continuing beyond 2-3 years. It is once again reiterated that rotational transfers of officers continuing beyond 3 years may be strictly carried out from the sensitive seats/ posts. It is clarified that the Commission's advice is from change from the sensitive seat/ post and not necessarily from the station.

All Vigilance Heads are requested to submit compliance in this regard in their monthly report.
