With the approval of the Competent Authority, it has been decided to hold a Limited Internal Competitive Examination (LICE) in offline mode for promotion to the Cadre of Telecom Technician (Erstwhile Telecom Mechanic) to be held on **08-Sep-2019 in order to fill up the vacancies for the vacancy upto 31.03.2019** as per the provision in the **Recruitment Rules of Telecom Technician (Erstwhile Telecom Mechanic)** circulated vide BSNL Corporate Office Letter **No. 250-3/2012-PERS-III dated 19.9.2012**; the **scheme & Syllabus** circulated vide BSNL Corporate Office Letter **No. 250-74/2001-Pers-III (part) dated 18th Oct 2011** shall be applicable for same (**enclosed at Annexure-A & B respectively**).

2. The recruitment year of the LICE for Telecom Technician shall be 2018. The crucial date shall be 01.07.2018 for reckoning the eligibility of candidate for appearing in the LICE, as conveyed by BSNL Corporate Office Letter No. 250-2/2014-Estt-III dated 22nd Feb 2019.

3. The examination will be conducted through written mode and as per revised Scheme and syllabus of examination circulated vide BSNL CO Lr no. 250-74/2001-PERS-III(Part) dated 18th Oct 2011 (**enclosed at Annexure-B**). The details of Papers and Time Table of the examination will be as under :-

4. There will be **negative marking** and for each wrong answer **25%** of the mark of that question shall be deducted.

5. **Minimum qualifying marks prescribed is 30% in each part and 37% in aggregate in respect of 'OC/OBC' candidates and 20% in each part and 30% in aggregate in respect of 'SC/ST' candidates.**

6. The eligibility for appearing in the above mentioned Limited internal Competitive Examination shall be as per existing Recruitment Rules issued by BSNL Corporate Office Letter **No. 250-3/2012-PERS-III dated 19th Sep 2012 (enclosed at Annexure-A).**

7. As per the BSNL CO, ND, letter at Ref.1 , the LICE for promotion to the cadre of Telecom Technician(**Erstwhile Telecom Mechanic**) to be held in those SSAs

(i) Where there is clear vacancy and no qualified and trained official is waiting for his/her absorption in the cadre of Telecom Technician for want of vacancies

and

(ii) there is no court case pending in connection with the LICE for Telecom Technician.

Applications in the proforma enclosed at **Annexure-C** may therefore be called for from all the eligible candidates, as specified in column number 12 of Recruitment Rules 2012 of Telecom Technician (**Erstwhile Telecom Mechanic**) by fixing the starting date of application as **15.07.2019** and the last date for submission of applications as **14.08.2019**.

9. **Application proforma (Annexure-C)** is also enclosed for this letter. Applications will be considered only in the stipulated period mentioned above i.e. from **15-07-2019** to **14-08-2019**. Candidates will have to provide valid details as per **Annexure-C**.

10. The prescribed Examination fee of Rs 500/- (Rupees Five hundred only) for Gen/OBC candidates and Rs 250/- (Rupees Two Hundred and Fifty only) for SC/ST candidates shall be paid by candidates through Demand Draft/Online mode of payment in favour of AO cash of the concerned SSA.

11. The amount of fee shall not be accepted in any other form. Fee once paid shall not be refunded under any circumstances nor can be held reserved for any other examination. Hence , the candidates are requested to ensure their eligibility for the said LICE before applying for the same. And under any condition, applications received after the closing date i.e., 14.08.2019 and applications received without valid Examination fee should not be entertained.

12. SSAs are hereby requested to complete the scrutiny of the applications received by the said due date , with Service Records/ ERP of the applicants as per the prevailing guidelines, and intimate the number of provisionally eligible candidates appearing the LICE along with the master data of the candidates as per the proforma enclosed at Annexure-D by 19.08.2019. Crucial date for determining the eligibility for appearing the said LICE is 01.07.2018.

13. Applications received from the candidates need not be sent to this office and are to be preserved at the SSA and required to be sent to this office as and when called for.

14. Applications received from the officials, who are working on deputation are to be forwarded immediately to the respective recruiting SSA/Unit concerned. And also, applications received in the non-recruiting Units are to be forwarded to the respective recruiting SSA/Unit concerned without any delay.

15. Venue of the examination, Admit card numbers & format, instructions to the candidates will be supplied to the SSAs concerned , so as to issue the Admit cards to all eligible candidates much before the scheduled date of examination.

16. The applicants would be admitted to the examination on the basis of the information furnished by them in their registration form. All the Candidates are, therefore, advised to ensure the fulfilment of all eligibility conditions before applying. In case it is found at a later stage that the information furnished by an applicant is false or an applicant does not fulfil any of the eligibility conditions, the candidature of such applicants would be cancelled even if the candidate qualifies in the LICE and no correspondence in this regard would be entertained.

17. Issuance of a Admit card for the examination will NOT confer any right for promotion or otherwise. Promotion will be solely provisional subject to the fulfilment of all eligibility conditions/vacancy/merit.

18. No electronic gadget or mobile phone etc. will be permitted to be taken inside the examination premises by the candidates.

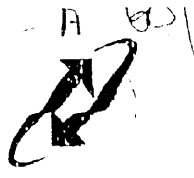

Recruitment Rules of Telecom Mechanic in BSNL

New Delhi, the 19th September 2012

1. **Short Title and commencement:**

- (i) With the approval of BSNL Board and in supercession of the Recruitment Rules of Telecom Mechanic-2002, the following rules regulating the method of recruitment to the post of Telecom Mechanic in BSNL are hereby made, namely
- (ii) These rules may be called the Telecom Mechanic (Recruitment) Rules, 2012.
- (iii) These rules shall come into force from the date of their publication and shall also be applicable to all Limited Departmental Competitive Examinations to be notified in future after publication of these Recruitment Rules by the Company.

2. **Definition:** In these Rules unless the context otherwise requires,

- (i) **Company:** Means the Bharat Sanchar Nigam Limited (A Government of India Enterprise) having its Registered Office at Bharat Sanchar Bhawan, Janpath, New Delhi.
- (ii) **Board:** Means the Board of Directors of the Company and includes in relation to the exercise of powers any Committee of the Board/Management or any other Officer of the Undertaking to whom the Board delegates any of its power.

3. **Application:** These Rules shall apply to the posts as specified in Column (1) of the Schedule annexed to these Rules.

4. **Number of posts, Classification and scale of pay--** The number of the said post, its classification and the scale of pay attached thereto shall be as specified in Column 2 to 4 of the Schedule annexed.
5. **Method of Recruitment, age limit, qualifications etc.----**
The method of recruitment, age limit, qualification and other matters relating to the said post shall be specified in Column 5 to 13 of the Schedule annexed.
6. **Disqualification**----No Person:-
- a) who has entered into or contracted a marriage with a person having a spouse living, or
- b) who having a spouse living, has entered into or contracted marriage with any person,
- Shall be eligible for appointment to the said posts;
7. **Pre-appointment training:-** The selected candidates before appointment shall have to successfully undergo the prescribed training for such period as may be specified from time to time by the BSNL. The officials who fail to complete the training successfully will not be promoted/appointed as Telecom Mechanic.
8. **Liability to serve under the P&T (Territorial Army) Signal Units:----**All candidates shall, if so required, be liable to serve in the Posts and Telegraphs (territorial Army) Signal Units as provided in the Territorial Army Act 1948 (56 of 1948) and the rules made there under.
9. **Saving:----**Nothing in these rules shall affect reservations, relaxation of age limited and other concession required to be provided for the Scheduled Castes, Scheduled Tribes, Other Backward Classes, Ex-Serviceman and other special category of persons in accordance with the orders issued by the Central Government from time to time in this regard.

10.

Initial constitution:-

- (i) All officials holding the posts of Telecom Mechanics on regular basis in the erstwhile DoT/DTS/DTO before commencement of these rules and those who have been absorbed in Bharat Sanchar Nigam Limited shall be deemed to have been appointed as Telecom Mechanic in BSNL.
- (ii) The continuous regular service of officials referred to in sub-rule 10(i) above before the commencement of these rules shall count for the purpose of Probation, Qualifying service for promotion, Confirmation and Pension.

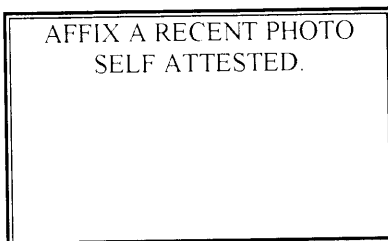
