In accordance with the aforesaid letters, I am directed to convey the approval of competent authority, for holding **LDCE on 20-08-2017** for promotion to the cadre of Telecom Technician (erstwhile TM) for the recruitment year 2016 to fill up the vacancies calculated up to 31-03-2017.

The said examination will be held in accordance with the Recruitment Rules for Telecom Mechanic - 2012 issued vide CO, ND Lr No 250-3/2012-Pers-III dated 19-09-2012 and the scheme / syllabus issued vide CO, ND Lr No 250-74/2001-Pers-III (Part) dated 18-10-2011 and subsequent clarifications / guidelines received in this regard from BSNL CO ND, which have been circulated for information of all concerned.

Examination center will be at Hyderabad.

There will be Negative marking and for each wrong answer, 25% of the mark of that question shall be deducted. Each question will have four options for answer. Only one answer which is most appropriate has to be selected by the candidate.

The minimum qualifying marks for the said LDCE will be as follows.

For OC Candidates	For SC / ST Candidates
30% in each section and 37% in aggregate	20% in each section and 30% in aggregate

As per the BSNL CO, ND, said LDCE for promotion to the cadre of Telecom Technician (erstwhile Telecom Mechanic) to be held in those SSAs (i) where there is clear vacancies and no qualified and trained official is waiting for his/her absorption in the cadre of Telecom Technician for want of vacancies and also (ii) there is no court case pending in connection with the LDCE for Telecom Technician. **And under any condition, applications received after the closing date i.e., 15-07-2017 shall not be entertained.** SSAs are hereby requested to complete the scrutiny of the applications received by the said due date, as per the prevailing guidelines, and intimate the number of provisionally eligible candidates appearing the LDCE along with the master data of the candidates (Annexure – B) to the undersigned by 20-07-2017. Crucial date for determining the eligibility for appearing the said LDCE is 01-07-2016.

Applications received from the candidates need not be sent to this office and are to be preserved at the SSA and required to be sent to this office as and when called for.

Applications received from the candidates, who are working on deputation are to be forwarded immediately to the respective recruiting SSA / Unit concerned. And also, applications received in the non – recruiting Units are to be forwarded to the respective recruiting SSA / Unit concerned without any delay.

Venue of the Examination, Admits card numbers & format, instructions to the candidates will be supplied to the SSAs concerned, so as to issue the Admit cards to all eligible candidates much before the schedule date of examination.

The applicants would be admitted to the examination on the basis of information furnished in their application form. They are, therefore, advised to ensure that they fulfill all eligibility conditions before applying the LDCE. In case, it is found at a later stage that, the information furnished by any applicant is false or an applicant does not fulfill any of the eligibility conditions, the candidature of such applicants would be cancelled even if the candidate qualifies the LDCE and no correspondence in this regard would be entertained.

Issuance of Hall Ticket will not confer any right for promotion or otherwise. Promotion will be solely provisional subject to fulfillment of all eligibility conditions.
