BSNL Corporate Office has published a merit list of the qualified candidates on the basis of revised answer key vide letter number cited under reference-1, in which 169 candidates have been qualified in "OC" against 156 notified vacancies in "OC" category. Therefore, 13 left out qualified candidates have not been effected promotion due to non- availability of vacancies in "OC" category. In the meanwhile, four "OC" category candidates have been declined their promotion as JAO and therefore four resultant vacancies have arisen in the aforesaid LICE.

The CGMT, TS Circle , Hyderabad has examined the subject matter in accordance with the instructions received from BSNL CO ND vide Lr. Nos.cited under reference-2,3 & 4 and decided to fill the resultant vacancies that have arisen due to the declining of some candidates with the left out qualified candidates as an exceptional case and without reference to any other examination already completed / to be completed in future.


