Subject: Review of policy of concessional telephone facilities for retired employees of DoT and extension of the same to pensioners of erstwhile P&T Department. - reg.

This department is considering the proposal of review of policy of concessional telephone facilities for retired employees of DoT and extension of the same to pensioners of erstwhile P&T Department.

- In this connection, Hon'ble MOS(I/C) has desired to know the following:
 - The current monthly expenditure being incurred (in terms of bill amount) for (i) providing concessional telephone facilities under RE-DOT category to DoT retirees as on date.
 - The current monthly expenditure being incurred (in terms of bill amount) for (ii) providing concessional telephone facilities under RE-DOT category to the retirees of erstwhile P&T Department/Department of Post who have completed 20 years or more service in erstwhile P&T Department as on date. These pensioners are currently not eligible for concessional telephone facilities under RE-DoT category but have been provided telephone facilities on the directions of various Courts/Tribunals.
 - The likely monthly expenditure going to be incurred (in terms of bill amount) for (iii) extending the concessional telephone facilities under RE-DOT category to all the retirees of erstwhile P&T Department/Department of Post who have completed 20 years or more service in erstwhile P&T Department. There are approximately 1,32,000 retirees of erstwhile P&T Department/Department of Post who have completed 20 years or more service in erstwhile P&T Department

In view of the above, it is requested that the above said requisite information be provided urgently to this office positively by 5 P.M today for onward submission to Hon'ble MOS(I/C). This may be treated as TOP PRIORITY.
