**Sub: Formation of Councils, viz, National Council, Circle Councils and Local Councils -
composition thereof - regarding**

Consequent upon conduct of 9th membership verification and grant of recognition to BSNL Employees Union (BSNLEU) and National Federation of Telecom. Employees BSNL(NFTE BSNL) in terms of this office notification of even number dated 17th October, 2022, it has been decided to constitute Councils, viz. National Council, Circle Council and Local Councils.

2. In accordance with the provisions of Part (VII) of BSNL Recognition of Non-Executives' Unions and Representation in the Councils Rules, 2012 and taking into account the percentage of votes secured by the above-mentioned recognized unions, BSNL Employees Union shall nominate eight (8) members and NFTE BSNL shall nominative Six (6) members from the Staff Side in the Councils. Taking note of this office letter no. BSNL/9-5/SR/2013 dated 27th June, 2013, the unions shall ensure that all the members are nominated from their own unions, which have been recognized in the 9th membership verification.
3. While making nominations to the Councils, the recognized representative unions are expected to take into account the provisions of Parts (VI) and (VII) of BSNL Recognition Rules Referred to above.

Ref : This office letters of even no. dated 27.03.2017, 05.07.2017 and 20.12.2017 along with FAQ.

In view of importance of Circle and Local Council meetings, SR Branch BSNL CO had requested to submit the quarterly report by 15th of July, October, January and April. FAQ on the matter was also uploaded on BSNL Intranet in Jan., 2017 and updated in Jan., 2018. Subsequently, vide above referred letters dated 27.03.2017, 05.07.2017 and 20.12.2017, it was requested to submit the reports on Circle/Local Council meetings during each quarters of FY 2017-18.

2. The frequency of holding meetings of Circle Council should be in three months and Local Councils in two months as per 'BSNL Recognition of Non-Executives' Union and Representation Rule. In this regard Q 9 & Q. 14 of FAQ on Constitutions of Councils available on www.intranet.bsnl.co.in at SR Home under "National Council" category may be referred.

3. The importance of this process is that it has been incorporated as KPIs(Key Performance Indicators) in GPMS Score Card of HR Group of BSNL CO and non-holding of the same will result in low performance in GPMS Score Card.

4. It is, therefore, requested to hold the Circle/Local Council meetings and all other formal meetings with recognised unions on regular basis as prescribed in the Rules and adhere to the time limit for submission of quarterly report to this office. Persistent Non-compliance of the requirement under the said Rules shall be viewed seriously and should reflect in the APARs of the concerned officials/officers.
