- II. Committee recommended the following points in addition to the creation of new field divisions:
- 1. Category-II BAs i.e., Guntur, Vijayawada and Visakhapatnam shall have DE(Tx-Mtce) at the BA HQs. Remaining divisions in these Cat-II BAs and all divisions in all other BAs shall have exclusive Tx-Mtce teams under the control of the respective field DEs.
- 2. In view of the large scale OFC rehabilitation works expected to be taken up in all BA/OAs, an exclusive AGM/DE(Tx-Projects) shall be available in every BA.
- 3. DE O&M at HQ shall maintain all O&M activities at Urban areas & Second line Mtce. at all rural areas.
- 4. JTOs and SDEs shall work independently and both shall report to AGM/DE(Second level).
- 5. One DE at the HQs of the BA shall be nominated as DE(Task Force) and shall act as a nodal officer to complete L&B activities including mutation etc., renting/sale of land assets and sale of non-moving, surplus, obsolete, unserviceable materials to earn revenues apart from making our premises clean and tidy.
- 6. Every OA should be headed by a DGM and he should be assisted by two AGMs.
- 7. To the extent possible field DEs shall not be assigned AGM duties in the O/o BA/OA HQs.
- 8. Newly created divisions out side the HQs of the BA/OA shall be filled with the Incoming/Promoted AGMs posted to BA/OA to the extent possible.
- 9. By re arrangement of existing AGM/DE posts, additional Field DEs, DE (Tx Projects) and DE (Task Force) posts can be met to the extent possible by making Looking after arrangement after obtaining approval from CO VJ or by giving additional charge to the SDE/DEs available locally by BAs.

Hence, all the BA heads are requested to implement the recommendations of the committee for achieving the assigned targets and also maintaining the services as per the QOS parameters.
