Transfers and Postings in respect of the JTOs (Telecom) are hereby ordered with immediate effect as mentioned in the Annexure. The prescribed tenure stay of executives posted to tenure / non-tenure stations will be governed by the BSNL Corporate Office, New Delhi guidelines issued from time to time.

The BA Heads/Unit Heads are requested to relieve the executives immediately without waiting for the substitutes upon completion of the tenure period. The leave, if any requested by the executives, under transfer, should not be allowed, if the executives desires leave, they can apply for it to the Competent Authority only after joining the new posting and the Competent Authority at the new place of posting will only sanction leave, if considered justified, in the normal course.

In case of any executive released but not joined in his/her new assignment and occupying departmental accommodation, having service Telephone (Fixed or Mobile) should be allowed only for a period for which he/she is eligible and thereafter all such facilities should be disconnected or charges be levied as per departmental norms.

Necessary charge reports may be forwarded to all the concerned and entries may be made in ERP/SAP and Service Records.

Before relieving, completion of tenure period as applicable, may please be ascertained.


