Kind attention is drawn to this office OM of even no. dated 05-01-2026 and subsequent reminder dated 23-01-2026 whereby all the Executives / non-Executives of BSNL were requested to submit their Immovable Property Returns (IPRs) for the year 2025 (as on 31-12-2025) latest by 31-01-2026.

2. It is however observed by the office of CVO, BSNL that a considerable number of employees have not submitted their Immovable Property Return (IPR) for the year ending 31-12-2025 and a significant number of employees are defaulting in submission of IPR in the past years also.

3. The office of CVO, BSNL has taken it seriously and vide their letter no. No. 22-05/2026/VA/Audit(viii) dated 26-05-2026 directed that a list may be prepared for the employees who have not filed the IPR and it may also be intimated what action has been initiated or to be initiated against those not filing the IPR, further, the cases of ghost employees may also be checked.


Sub: Filing the Immovable Property Return(IPR) and appropriate action for not filing the IPR.
